WAIVER AND RELEASE OF LIABILITY**

READ BEFORE SIGNING

AND NOW, this _____, day of _____, 20____, in consideration of being allowed to participate in any way in the use of the facilities and/or related events and activities of the Northumberland and Point Township Sportsman's Association (hereinafter "NPTSA"), the undersigned acknowledges, fully understands, and agrees that:

1) I hereby acknowledge that the risk of injury from the use of firearms and other known and unknown events and activities and/or the use of the firearms-related structures, premises, equipment, and all other real and personal property whether owned by NPTSA or others is significant, including the potential for permanent paralysis and death, and while particular rules, equipment, and personal discipline may reduce this risk, the risk of serious injury does exist; and,

2) I acknowledge and agree that the use of firearms and/or related equipment by myself or others on the premises comprising NPTSA, or otherwise, are inherently dangerous and high risk activities whether such firearms or other equipment is discharged by myself or others; and

3) I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF OTHERS, and assume full responsibility for my participation; and,

4) I willingly agree to comply with the stated and customary terms and conditions for participation. If, however, I observe any unusual significant hazard during my presence or participation, I will remove myself from participation and bring such to the attention of the nearest NPTSA officer immediately; and,

5) I fully understand and agree that this Release and Waiver shall be held in the files of the NPTSA, and shall be considered ongoing for all future uses of NPTSA assets, equipment, or facilities.

6) I, for myself and on behalf of my heirs, assigns, personal representatives and next of kin, HEREBY RELEASE AND HOLD HARMLESS the Northumberland and Point Township Sportsman's Association (NPTSA), its officers, directors, officials, agents, employees, volunteers, members, guests, other participants, sponsoring agencies, sponsors, advertisers, and owners and lessors of real property and/or personal property used in conjunction with the activities of the NPTSA ("RELEASEES"), WITH RESPECT TO ANY AND ALL INJURY, DISABILITY, DEATH, OR LOSS OR DAMAGE TO PERSON(S) OR PROPERTY, WHETHER ARISING FROM THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE, TO THE FULLEST EXTENT PERMITTED BY LAW.

I HAVE READ THIS RELEASE OF LIABILITY AND ASSUMPTION OF RISK AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND SIGN IT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT.
